CODE ENFORCEMENT OFFICER IN TRAINING UPGRADE REGISTRATION INSTRUCTIONS

- <u>NAME</u> Provide your legal name in the spaces provided. (Last Name, First Name, Middle Name, Suffix) Examples
 of a suffix include Jr., Sr., and II. (Mr. is not a suffix.)
- 2. <u>DATE OF BIRTH</u> Provide your birthdate.
- SOCIAL SECURITY NUMBER Social Security Number disclosure is required by Section 231.302(c)(1) of the Texas Family Code in order to obtain a license. Your Social Security Number is subject to disclosure to an agency authorized to assist in the collection of child support payments. For more information regarding child support payments, contact the <u>Texas Attorney General</u>.
- 4. CODE ENFORCEMENT OFFICER IN TRAINING NUMBER Provide your CEO in Training registration number.
- 5. <u>EMAIL ADDRESS</u> Provide your email address only if you agree to the following statement. By providing my email address I authorize the Texas Department of Licensing and Regulation (TDLR) to send licensing communications and required notices to me by electronic mail. I understand that I may revoke this authorization in writing and that I must update my email address, or I will not receive these notices. I understand that the email address I have provided in this application will remain confidential except as permitted or required by law.
- 6. <u>PERSONAL PHONE NUMBER</u> Provide a telephone number, including the area code, where we can reach you during the day. This may be your office phone number where we can leave a message.
- 7. MAILING ADDRESS Provide your current residential mailing address. This is the address where we will send you mail. This address can be a post office box. Add the zip plus-4 to help the postal service deliver mail more efficiently and accurately.
- 8. <u>DISCIPLINARY ACTION HISTORY</u> Indicate if you have ever had a professional license, certification, or registration suspended, canceled, revoked, or denied in any state. If you have, complete and attach a <u>Disciplinary</u> Action Questionnaire (PDF) for each disciplinary action.
- CRIMINAL HISTORY Indicate if you have ever been convicted of or placed on deferred adjudication for any Misdemeanor or Felony, other than a minor traffic violation. If YES, complete and attach a <u>Criminal History</u> Questionnaire (PDF) for each offense.
- 10. STATEMENT OF APPLICANT Carefully read the statement before signing and dating your application.

UPGRADING TO A REGISTERED CODE ENFORCEMENT OFFICER:

A registered code enforcement officer in training who has obtained one year of full-time experience in the field of code enforcement may file an application to upgrade a registration to that of code enforcement officer. Upon payment of the required fee and approval by the department, the applicant shall be granted registration as a code enforcement officer.
