## OFFENDER EDUCATION PROGRAM ENDORSEMENT APPLICATION INSTRUCTIONS

Each entity requesting to add an Offender Education Program endorsement shall provide an application for approval that shall be in compliance with 16 TAC 90 and TDLR established guidelines.

- 1. LEGAL NAME OF PROGRAM Enter the legal name of the program.
- 2. <u>APPLICATION FEE</u> \$280.00 (NON-REFUNDABLE)
- 3. <u>DBA NAME OF PROGRAM</u> Enter the DBA name of the program if the legal name of the program differs. This is the name that is used in advertisements.
- 4. PROGRAM CERTIFICATION NUMBER Enter the Program Certification Number
- OFFENDER EDUCATION PROGRAM Indicate program application type and indicate if the course will be offered in Spanish. A separate application will need to be submitted for each license type.
- 6. <u>PROGRAM HEADQUARTERS MAILING ADDRESS AND CONTACT INFORMATION</u> Enter the mailing address. This address is where the Department will mail all correspondence and may be a post office box.
- 7. INSTRUCTOR INFORMATION List all instructors associated to the program.
- 8. <u>STATEMENT OF APPLICANT</u> Application must be signed by the owner, officer or other authorized representative. You must print your name, sign and date the application.
