### RESIDENTIAL APPLIANCE INSTALLER LICENSE APPLICATION INSTRUCTIONS

DOCUMENTS SUBMITTED WITH YOUR APPLICATION WILL NOT BE RETURNED. KEEP A COPY OF YOUR COMPLETED APPLICATION, ALL ATTACHMENTS, AND YOUR CHECK OR MONEY ORDER.

- 1. NAME Provide your legal name in the spaces provided. (Last, First, Middle Name, Suffix) Examples of a suffix include Jr., Sr., and III. (Mr. is not a suffix.)
- DATE OF BIRTH Provide your birthdate.
- 3. GENDER Select whether you are male or female.
- 4. <u>SOCIAL SECURITY NUMBER</u> Social Security number disclosure is required by Section 231.302(1) of the Texas Family Code in order to obtain a license. Your social security number is subject to disclosure to an agency authorized to assist in the collection of child support payments. For more information regarding child support payments, contact the <u>Texas Attorney General</u> or call (512) 460-6000 or (800) 252-8014.
- 5. MAILING ADDRESS Provide your current mailing address. This is the address where we will send you mail. This address can be a post office box. You can add the zip plus-4 to help the postal service deliver mail more efficiently and accurately.
- PHYSICAL ADDRESS Provide your physical address of your residence. Do not use a post office box for this
  address.
- 7. <u>PHONE NUMBER</u> Provide a telephone number, including the area code, where we can reach youduring the day. This may be your office phone number where we can leave a message.
- 8. <u>EMAIL ADDRESS</u> By providing my email address I authorize the Texas Department of Licensing and Regulation (TDLR) to send licensing communications and required notices to me by electronic mail. I understand that I may revoke this authorization in writing and that I must update my email address, or I will not receive these notices. I understand that the email address I have provided in this application will remain confidential except as permitted or required by law.
- CRIMINAL HISTORY Indicate if you have ever been convicted of, or placed on deferred adjudication for, any
  Misdemeanor or Felony, other than a minor traffic violation. If YES, complete and attach a <u>Criminal History</u>
  <u>Questionnaire (PDF)</u> for each offense.
  - If you are worried your criminal history could prevent you from getting this license, Texas allows you to have your criminal history evaluated before you submit your application and pay non-refundable fees. To request a criminal history evaluation, submit a <u>Criminal History Evaluation Letter (PDF)</u>, a completed <u>Criminal History Questionnaire</u> (<u>PDF</u>) for each crime you were convicted of, or placed on deferred adjudication for, and a \$10.00 fee.
- 10. <u>DISCIPLINARY ACTION HISTORY</u> Indicate if you have ever had a professional license, certification, or registration suspended, revoked, or denied in any state. If Yes, complete and attach a <u>Disciplinary Action Questionnaire</u> (<u>PDF</u>) for each disciplinary action.
- 11. STATEMENT OF APPLICANT Carefully read the statement before dating and signing your application.

APPLICATION INFORMATION FOR MILITARY SERVICE MEMBERS, MILITARY VETERANS AND MILITARY SPOUSES The Texas Department of Licensing and Regulation recognizes the contributions of our active-duty military service members, their spouses, and veterans.
