MASTER ELECTRICIAN LICENSE BY RECIPROCITY APPLICATION INSTRUCTIONS

Use this application only if the applicant currently holds an electrician license equivalent to a Texas masters electrician license. in a state that has a reciprocity agreement with Texas.

DOCUMENTS SUBMITTED WITH YOUR APPLICATION WILL NOT BE RETURNED. KEEP A COPY OF YOUR COMPLETED APPLICATION, ALL ATTACHMENTS, AND YOUR CHECK OR MONEY ORDER.

- 1. <u>NAME</u> Your name must match your government ID or driver license. (Last, First, Middle Name, Suffix) Examples of a suffix include Jr., Sr., and III. (Mr. is not a suffix.)
- SOCIAL SECURITY NUMBER Disclosure is required by the <u>Texas Family Code</u> in order to obtain a license. Your social security number is subject to disclosure to an agency authorized to assist in the collection of child support payments. For more information regarding child support payments, contact the <u>Texas Attorney General</u>.
- 3. DATE OF BIRTH MM/DD/YYYY
- 4. GENDER Select whether you are male or female.
- 5. <u>PHONE NUMBER</u> Provide the phone number where you can be reached during the day. This should be a phone number where we can leave a message.
- 6. <u>EMAIL ADDRESS</u> Provide your email address to receive licensing communications and required notices by electronic mail and keep a valid email address on file.
- MAILING ADDRESS Provide your current mailing address. This is the address where we will send you mail. This
 address can be a post office box. Always keep your mailing address current with the Texas Department of Licensing
 and Regulation (TDLR).
- 8. PHYSICAL ADDRESS This is the physical location of your residence. Do not use a post office box for this address.
- 9. <u>CRIMINAL HISTORY</u> Indicate if you have ever been convicted of, or placed on deferred adjudication for, any Misdemeanor or Felony, this does not include a minor traffic violation. If YES, complete and attach a <u>Criminal History</u> <u>Questionnaire (PDF)</u> for each offense.
 - If you are worried your criminal history could prevent you from getting this license, you may have your criminal history evaluated <u>before</u> you submit this application and non-refundable fees. To request a criminal history evaluation, do not send this application. Submit a <u>Criminal History Evaluation Letter (PDF)</u>, a completed <u>Criminal History Questionnaire</u> (<u>PDF</u>) for each crime you were convicted of, or placed on deferred adjudication for, and the required fee.
- DISCIPLINARY ACTION HISTORY Indicate if you have ever had a professional license, certification, or registration suspended, revoked, or denied in any state. If Yes, complete and attach a Disciplinary Action Questionnaire (PDF) for each disciplinary action.
- 11. <u>OUT-OF-STATE LICENSING INFORMATION</u> Provide the information about your current out-of-state license. Check the out-of-state Electrician Reciprocity site before submitting this application. Your fee will not be refunded if there is not a reciprocity agreement with your out of state board.
- ACKNOWLEDGEMENT OF APPLICANT Carefully read the acknowledge of applicant before you sign and date your application.
