## MASTER ELECTRICIAN LICENSE BY RECIPROCITY APPLICATION INSTRUCTIONS

Use this application only if the applicant currently holds an electrician license equivalent to a Texas masters electrician license, in a state that has a reciprocity agreement with Texas.

**DOCUMENTS SUBMITTED WITH YOUR APPLICATION WILL NOT BE RETURNED. KEEP A COPY OF YOUR COMPLETED APPLICATION, ALL ATTACHMENTS, AND YOUR CHECK OR MONEY ORDER.**

1. NAME – Your name must match your government ID or driver license. (Last, First, Middle Name, Suffix) Examples of a suffix include Jr., Sr., and III. (Mr. is not a suffix.)
2. SOCIAL SECURITY NUMBER – Disclosure is required by the [Texas Family Code](#) in order to obtain a license. Your social security number is subject to disclosure to an agency authorized to assist in the collection of child support payments. For more information regarding child support payments, contact the [Texas Attorney General](#).
3. DATE OF BIRTH - MM/DD/YYYY
4. GENDER – Select whether you are male or female.
5. PHONE NUMBER – Provide the phone number where you can be reached during the day. This should be a phone number where we can leave a message.
6. EMAIL ADDRESS – Provide your email address to receive licensing communications and required notices by electronic mail and keep a valid email address on file.
7. MAILING ADDRESS – Provide your current mailing address. This is the address where we will send you mail. This address can be a post office box. Always keep your mailing address current with the Texas Department of Licensing and Regulation (TDLR).
8. PHYSICAL ADDRESS – This is the physical location of your residence. Do not use a post office box for this address.
9. CRIMINAL HISTORY – Indicate if you have ever been convicted of, or placed on deferred adjudication for, any Misdemeanor or Felony, this does not include a minor traffic violation. If YES, complete and attach a [Criminal History Questionnaire \(PDF\)](#) for each offense.  
If you are worried your criminal history could prevent you from getting this license, you may have your criminal history evaluated before you submit this application and non-refundable fees. To request a criminal history evaluation, do not send this application. Submit a [Criminal History Evaluation Letter \(PDF\)](#), a completed [Criminal History Questionnaire \(PDF\)](#) for each crime you were convicted of, or placed on deferred adjudication for, and the required fee.
10. DISCIPLINARY ACTION HISTORY – Indicate if you have ever had a professional license, certification, or registration suspended, revoked, or denied in any state. If Yes, complete and attach a Disciplinary Action Questionnaire (PDF) for each disciplinary action.
11. OUT-OF-STATE LICENSING INFORMATION – Provide the information about your current out-of-state license. Check the out-of-state Electrician Reciprocity site before submitting this application. Your fee will not be refunded if there is not a reciprocity agreement with your out of state board.
12. ACKNOWLEDGEMENT OF APPLICANT – Carefully read the acknowledge of applicant before you sign and date your application.
