## MOTOR FUEL METERING AND QUALITY DEVICE REGISTRATION APPLICATION INSTRUCTIONS

**KEEP A COPY OF YOUR COMPLETED APPLICATION, ALL ATTACHMENTS, AND YOUR CHECK OR MONEY ORDER PAYABLE TO TDLR.**

1. **APPLICATION TYPE** – Check the box that identifies the application type.

- A "New Business" application is for a business that has not held a device registration certification.
- A "Change of Ownership" application is for a business that has been transferred or acquired from a previous owner, or a registered business changing its federal tax identification number. Indicate the date of the change of ownership, and if known, the most recent account number.

2. **BUSINESS NAME** – Provide the full legal business name as it is registered with the Texas Secretary of State.

3. **FACILITY NAME** – Provide the name of the facility where the devices are located (if different from the Business Name). This may be the Doing Business As (DBA) name used by the business submitting this application.

4. **FACILITY PHYSICAL LOCATION** – Provide the physical street address of the facility location. Post office boxes will not be accepted. This information will assist the Texas Department of Licensing and Regulation (TDLR) staff in locating your business, if necessary.

5. **FACILITY PHONE NUMBER** – Provide a telephone number for the facility including the area code.

6. **DEVICE CLASSIFICATION** – Provide the total number of devices per type in commercial use at your business.

- a) Device with a maximum flow rate of less than 20 GPM delivering multiple products per nozzle (includes a fuel quality fee of \$21) \$93.
- b) Device with a maximum flow rate of less than 20 GPM delivering a single fuel product per nozzle (includes a fuel quality fee of \$7) \$31.
- c) Device with a maximum flow rate of 20 GPM to 100 GPM (includes a fuel quality fee of \$7) \$127.
- d) Device with a maximum flow rate of greater than 100 GPM \$450.

**NOTE: If the number of devices at your business decreases during the registration period, submit a [Change of Device Registration \(PDF\)](#) form to TDLR. No refunds will be made for devices permanently removed from commercial**

**use. FEES:**

- To calculate the Total Fee per Device Type, multiply the Total Number of Devices by the Fee per Device.
- To calculate the Total Fees Due, add all Total Fees per Device Type.

7. **BUSINESS TYPE** – Check the box that indicates how your business is organized.

8. **FEDERAL EMPLOYER ID NUMBER** – Provide the Federal Employer ID number that is used by your business.

Information about the Federal Employer ID numbers can be found by contacting the [Internal Revenue Service](#).

- **SOLE PROPRIETORS** – Social security number disclosure is required by Section 231.302(1) of the Texas Family Code to obtain a license. Your social security number is subject to disclosure to an agency authorized to assist in the collection of child support payments. For more information regarding child support payments, contact the [Texas Attorney General](#) or call (512) 460-6000 or (800) 252-8014.

9. **POINT OF CONTACT** – Provide the name, title, and contact information for the person who will be the point of contact for the business and can discuss and answer questions about registration related matters. Renewal invoices and account information, including correspondence, registration certificates, and other related documents, will be sent to the current contact information listed for the Point of Contact.

- **EMAIL ADDRESS** – By providing the point of contact’s email address, TDLR is authorized to send communications and required notices by electronic mail. To continue receiving notices, this email address must be updated, if necessary. This authorization may be revoked in writing. The email address provided will remain confidential except as permitted or required by law.
- **PHONE NUMBER** – Provide the Point of Contact’s telephone number, including the area code.
- **MAILING ADDRESS** – Provide the Point of Contact’s mailing address. The mailing address provided is where we will send registration-related mail. A post office box can be used.

10. **RESPONSIBLE PARTY** – Provide the name, title, and contact information of the person responsible for the business. The Responsible Party may include but is not limited to an officer, partner, manager, or owner of the business.

- **EMAIL ADDRESS** – By providing the responsible party’s email address, TDLR is authorized to send communications and required notices by electronic mail. To continue receiving notices, this email address must be updated, if necessary. This authorization may be revoked in writing. The email address provided will remain confidential except as permitted or required by law.
- **PHONE NUMBER** – Provide a telephone number, including the area code, for the Responsible Party.
- **MAILING ADDRESS** – Provide the mailing address for the Responsible Party. A post office box can be used.

11. **ACKNOWLEDGMENT** – After reading the statement, print your name and date the form. By providing your name, you acknowledge that you have read the statement and that you are aware of your responsibilities regarding the issuance of the requested device registration.

**CHECKLIST OF REQUIRED DOCUMENTATION TO BE SUBMITTED:**

- Completed Application
- Required Fee (Application will be returned if total amount fee is not included)
- Copy of Device Performance Review Report\*\*

\*\*A Device Performance Review (DPR) Report (formerly “Calibration Report”) must be submitted with this application. A DPR must be completed before a device may be placed into service and at least once every two years. Effective September 1, 2021, a DPR will also be required for devices with a flow rate of greater than 20 GPM – 100 GPM and devices with a flow rate greater than 100 GPM.

## ARE YOUR FUEL DEVICES CORRECTLY REGISTERED?

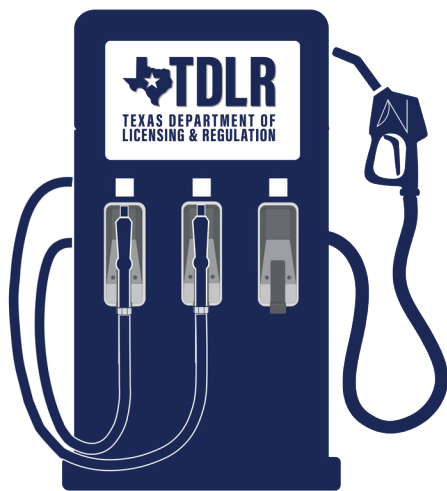
The Texas Department of Licensing and Regulation (TDLR) classifies devices that deliver fuel through a single nozzle at a rate of less than 20 gallons per minute (GPM) in two categories:

- Single product device; and
- Multi-product device.

To aid you in this classification process, listed below are common examples of fuel devices, including fee calculations.

Each nozzle represents a single device and most device cabinets have two sides, with nozzles on each side. Please remember to count and include all devices on your registration application.

**3 – Single Product Devices<sup>a</sup>**  
Fee: \$31 / nozzle

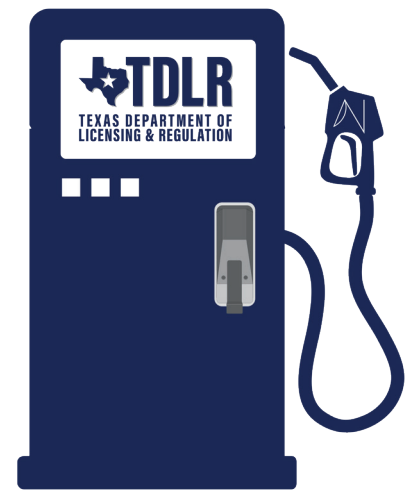
Total Fee / Cabinet: \$186  
(as illustrated above)  
2 sides x \$93 (\$31/device) = \$186



**Single Product Device<sup>a</sup>**  
Fee: \$31 / nozzle

**AND**  
**Multi-Product Device<sup>b</sup>**  
Fee: \$93 / nozzle

Total Fee / Cabinet: \$248  
(as illustrated above):  
2 sides x (\$31/device + \$93/device) = \$248



**Multi-Product Device<sup>b</sup>**  
Fee: \$93 / nozzle

Total Fee / Cabinet: \$186  
(as illustrated above):  
2 sides x \$93/device = \$186

### Notes:

- Single product device (includes a fuel quality fee of \$7) – \$31. A single product device delivers one gasoline, E85 ethanol fuel, diesel, or other non-gasoline product from a single nozzle.
- Multi-product device (includes a fuel quality fee of \$21) – \$93. A multi-product device delivers 2 or more blends of gasoline or ethanol-blended fuel from a single nozzle.
- These illustrations represent examples of device cabinets commonly found in the marketplace. TDLR does not endorse or recommend any brand of device cabinet.
