SERVICE CONTRACT ADMINISTRATOR REGISTRATION INSTRUCTIONS

DOCUMENTS SUBMITTED WITH YOU APPLICATION WILL NOT BE RETURNED. KEEP A COPY OF YOUR COMPLETED APPLICATION, ALL ATTACHMENTS, AND YOUR CASHIER'S CHECK OR MONEY ORDER.

- 1. NAME OF PROVIDER Provide the full name of the business to be registered (40 character maximum).
- 2. <u>ASSUMED NAME(S) OR DOING BUSINESS AS (DBA) NAME(S)</u> Enter all assumed names or DBAs used by the provider applying for registration. If you use an assumed name or DBA attach an Assumed Named Certificate from the Texas Secretary of State's Office or from the Texas county where you filed the DBA or assumed name.
- 3. TYPE OF OWNERSHIP Select the box that shows how the business is organized.
- 4. <u>FEDERAL TAX ID NUMBER</u> Enter the federal ID number that is used by the business. Information about Federal or Employer ID numbers can be found at <u>IRS website</u>.
- 5. <u>MAILING ADDRESS</u> Provide the current mailing address for the business. This is the address where we will send you mail. A post office box can be used.
- 6. PHYSICAL LOCATION Enter the physical address of the business. Do not use a post office box.
- 7. <u>BUSINESS PHONE NUMBER</u> Provide the main business phone number, including the area code, where we can reach you during the day or where we can leave you a message.
- 8. <u>BUSINESS FAX NUMBER</u> Enter the main business fax number, including the area code, where you can receive faxes.
- 9. <u>POINT OF CONTACT</u> Provide the name, title, email address, and phone number of a person we can contact about your business. Please provide your email address so the department may email license information and required notices to you. Your email address is confidential pursuant to the Texas Public Information Act, and the department will not share it with the public.
- 10. <u>SERVICE CONTRACT PROVIDER</u> List their name and Texas Service Contract Provider TDLR Registration Number. Attach additional sheets if necessary.
- 11. <u>CONTROLLING PERSONS</u> List all controlling persons associated with this Administrator. Answer all questions associated with each controlling person. Make additional copies as needed.
- 12. STATEMENT OF APPLICANT Carefully read the statement; print your name, and title; sign and date your application.
