CONTESTANT CONSENT AUTHORIZING DRUG TESTING & RELEASE OF RESULTS

authorize the attending medical/laboratory (lab) technician to collect and analyze the urine specimen I am providing. I authorize the lab to release the test results to:

- Texas Department of Licensing and Regulation (Department); and
- the sanctioning body and/or promoter of the event in which I participate as a contestant.

I authorize the Department to release my drug test results 60 days after the Department receives my results.

I authorize the Department to update Box Rec or the MMA Registry based on the results of my drug test prior to the 60th day after receipt of my drug test results.

In the event my specimen indicates a positive result for any of the substances listed in Texas Administrative Code, Chapter 61.47 (q) 1-1, or exceeds the thresholds established by the testing lab designated by the Department's Executive Director, I understand that an automatic 90-day medical suspension is in effect, and I authorize the Department to use my test results in a disciplinary proceeding to suspend or revoke my license and assess an administrative penalty.

I understand that if I refuse to provide a urine specimen, do not comply with the testing process, or try to substitute, dilute, mask or adulterate a urine specimen, my actions will be considered the same as having a positive test result, my license may be suspended or revoked, and I may be ordered to pay an administrative penalty.

I understand that I can withdraw my consent for the release of my test results at any time by giving the Department written notice of my decision to withdraw my consent.

URINE SPECIMEN TESTING PROCEDURES AND YOUR RIGHTS:

- At the collection site: The specimen will be divided into two bottles labeled as a primary "A" specimen and a secondary "B" specimen and transported to the testing lab.
- At the lab: Only the "A" specimen will be opened and used for the urinalysis. The "B" specimen will remain sealed.
- **Positive result:** You will be notified by the Department if analysis of the "A" specimen indicates a positive result, or exceeds the threshold established by the testing lab designated by the Department's Executive Director.
- **Right to re-test:** In the event the "A" specimen tests positive for a prohibited substance or exceeds the established threshold, **you have five calendar days after receiving notification of a violation to request that the "B" specimen be analyzed at another Department-approved lab.** If you do not make a request within five calendar days, you waive your right to have the "B" specimen analyzed and you will accept the 90-day suspension under Texas Administrative Code, Chapter 61.47 (q).
