COMBATIVE SPORTS JUDGE LICENSE APPLICATION INSTRUCTIONS

The application must be completed and signed by the applicant. An application is not considered complete and will not be processed until all required items have been submitted.

- 1. NAME Provide your legal name in the spaces provided. (Last, First, Middle Name, Suffix) Examples of a suffix include Jr., Sr., and III. (Mr. is not a suffix.)
- 2. <u>DATE OF BIRTH</u> Provide your birth date. You must be at least 21 years of age to be eligible for this license.
- 3. GENDER Select whether you are male or female.
- 4. <u>SOCIAL SECURITY NUMBER</u> Social security number disclosure is required by Section 231.302(c)(1) of the Texas Family Code in order to obtain a license. Your social security number is subject to disclosure to an agency authorized to assist in the collection of child support payments. For more information regarding child support payments, contact the <u>Texas Attorney General</u>.
- 5. <u>FOREIGN NATIONAL PASSPORT NUMBER</u> Applicants that are foreign nationals, must provide their passport number.
- MAILING ADDRESS Provide your current mailing address. This is the address where we will send you mail. This
 address can be a post office box. Add the zip plus-4 to help the postal service deliver mail more efficiently and
 accurately.
- 7. <u>PHONE NUMBER</u> Provide a telephone number, including the area code, where we can reach you during the day. This may be your office phone number where we can leave a message.
- 8. <u>EMAIL ADDRESS</u> Provide your email address. By providing my email address I authorize TDLR to send licensing communications and required notices to me by electronic mail. I understand that I may revoke this authorization in writing and that I must update my email address or I will not receive these notices. I understand that the email address I have provided in this application will remain confidential except as permitted or required by law.
- 9. <u>CRIMINAL HISTORY</u> Indicate if you have ever been convicted of, or placed on deferred adjudication for, any misdemeanor or felony, other than a minor traffic violation. If YES, complete and attach a <u>Criminal History</u> <u>Questionnaire (PDF)</u> for each offense. This form can be obtained from the <u>TDLR website</u>. If you are worried your criminal history could prevent you from getting this license, Texas allows you to have your criminal history evaluated before submitting your application and non-refundable fees. To request a criminal history evaluation, submit a <u>Criminal History Evaluation</u> <u>Letter (PDF)</u>, a completed Criminal History Questionnaire form for each crime you were convicted of, or placed on deferred adjudication for, and a \$10.00 fee.
- DISCIPLINARY ACTION HISTORY Indicate if you have ever had an occupational license, certification, or registration suspended, revoked, or denied in any state. If you have, complete and attach a *Disciplinary Action Questionnaire (PDF)* for each disciplinary action.
- 11. <u>DO YOU HAVE A DIRECT OR INDIRECT FINANCIAL INTERES</u>T Check YES or NO to indicate if you have any type of financial interest in management of a contestant, manager, or sanctioning body. If YES, attach a full explanation to your application.
- 12. <u>DO YOU HAVE THREE YEARS ACTIVE EXPERIENCE</u> Check YES or NO to indicate if you have three years of active experience as a judge or referee in the combative sport you seek endorsement by having officiated in at least ten combative sporting events per year. If YES, you must describe your experience in section 16.
- 13. <u>OUT-OF-STATE LICENSE</u> Check YES or NO to indicate if you are qualifying for a Texas judge license using an out-of-state judge license that the Executive Director has determined to be equivalent to Texas' requirements.
- 14. <u>PREVIOUSLY HELD A TEXAS JUDGE LICENSE</u> Check YES or NO to indicate if you are qualifying for a new Texas judge license by using an expired Texas judge license, that expired in good standing. If YES, provide your Texas judge license number.

- 15. <u>EYE EXAM</u> To obtain or renew a license, a judge must provide test results showing visual acuity in each eye of at least 20/40 corrected. The test must be performed by a licensed Optometrist or licensed Ophthalmologist no more than three years before the application for licensure or license renewal is filed.
- 16. <u>EXPERIENCE</u> If you answered YES to question 12, describe three years of active experience as a judge and/or referee officiating at least ten combative events per year.
- 17. STATEMENT OF APPLICANT Carefully read the statement before you sign and date your application.
